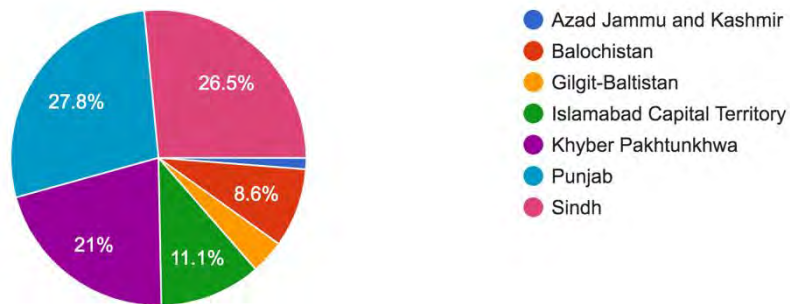

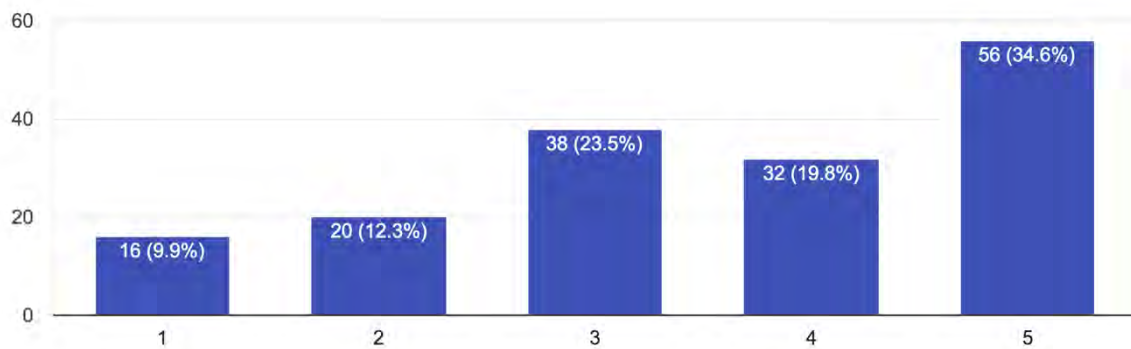
Which province your office is located?

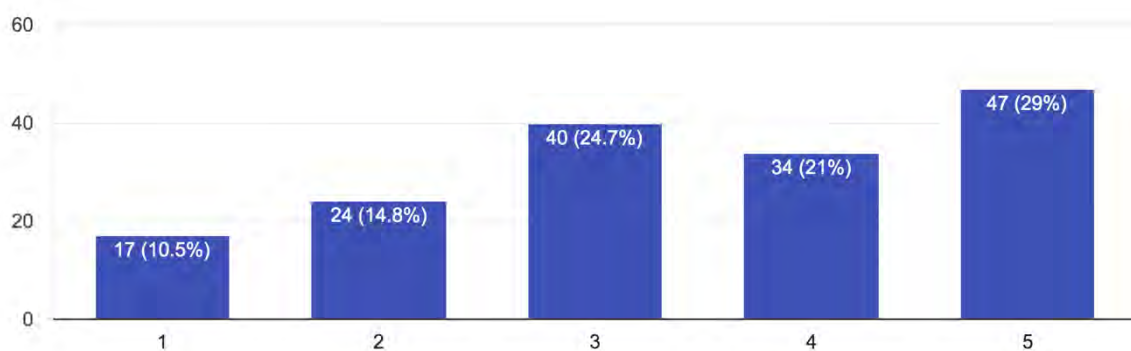

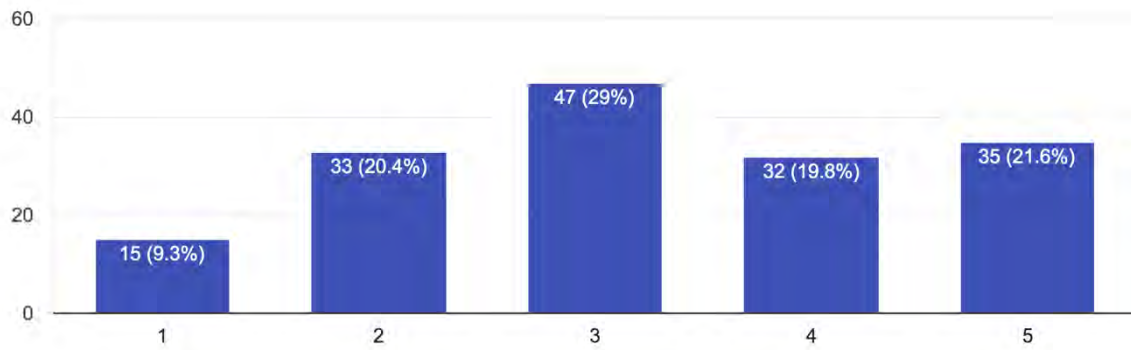
Q2. Do you feel free to speak to the media?

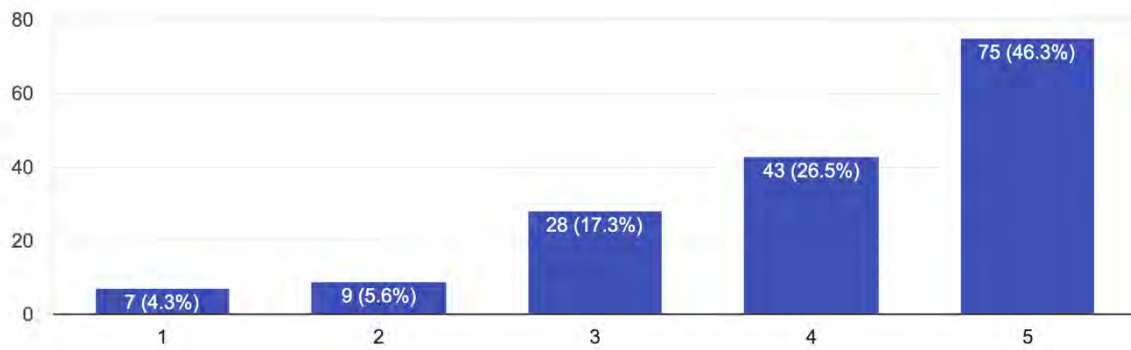

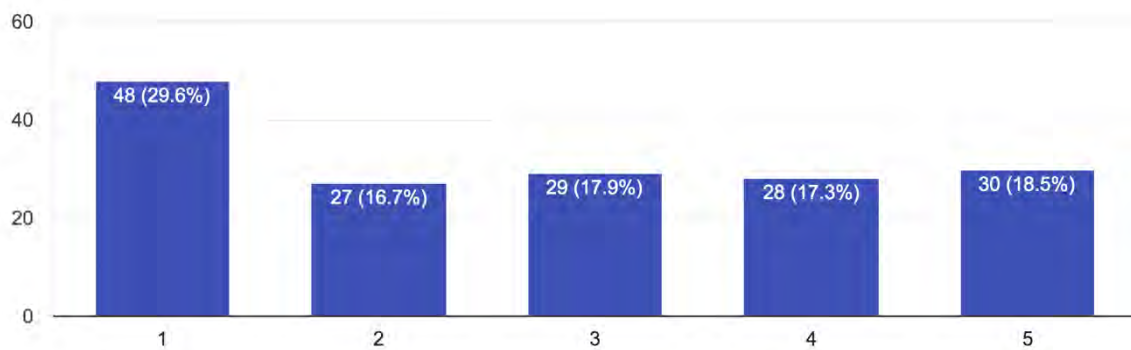

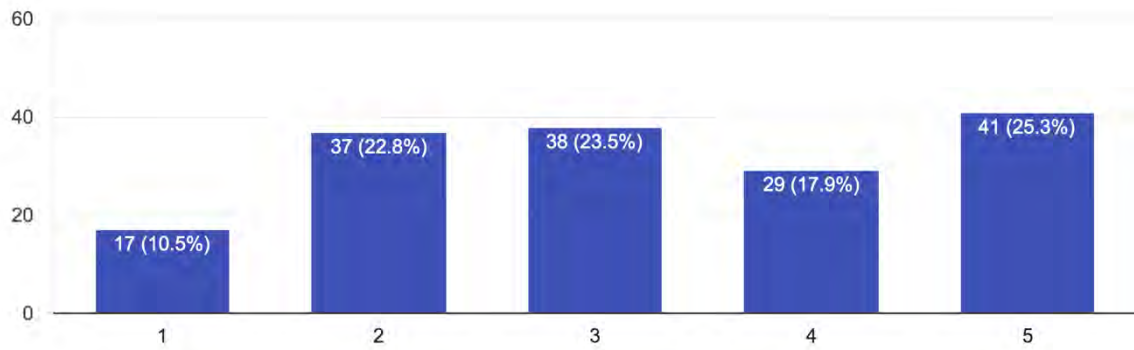

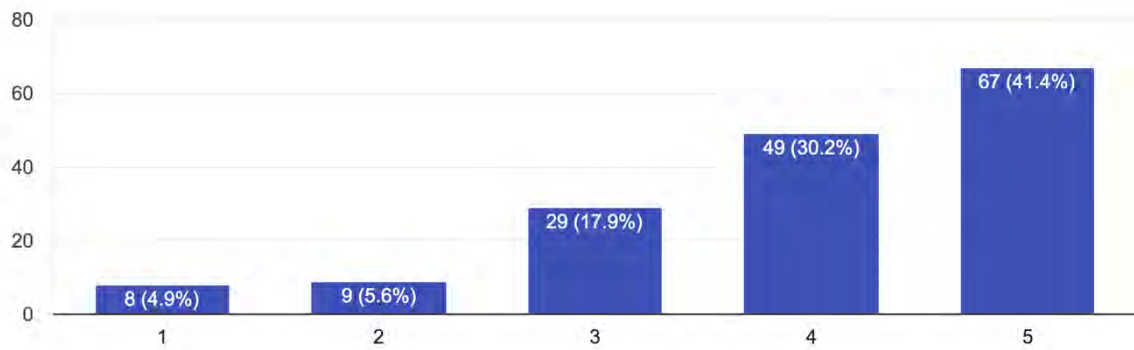

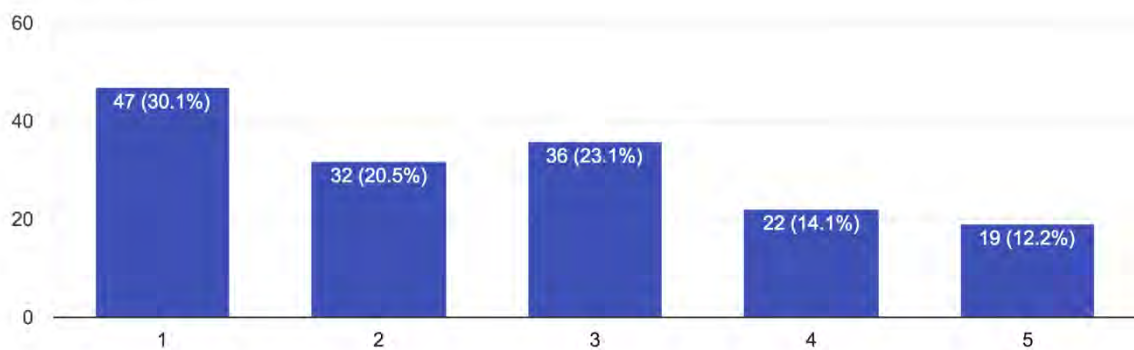

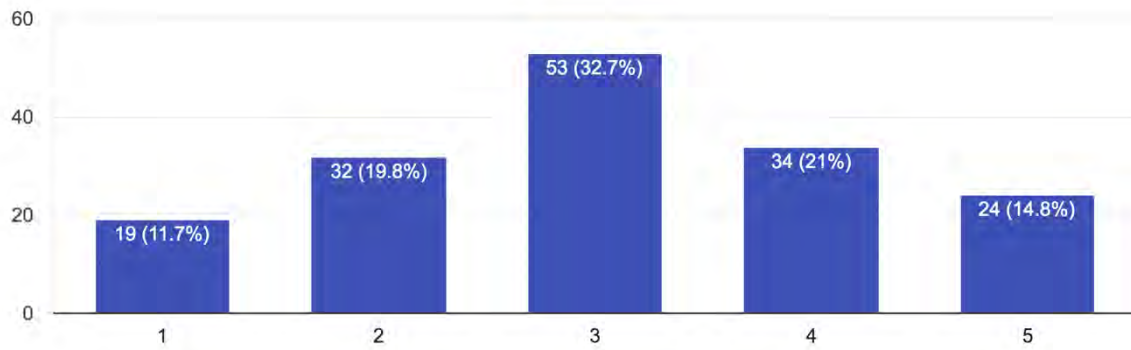

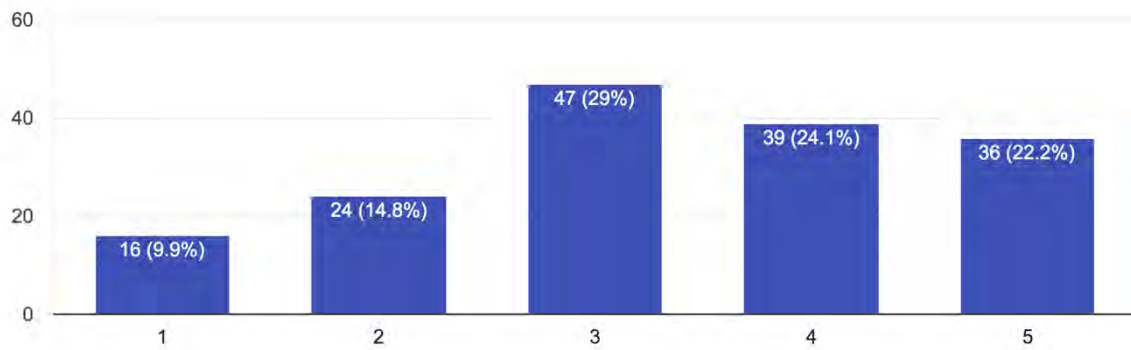

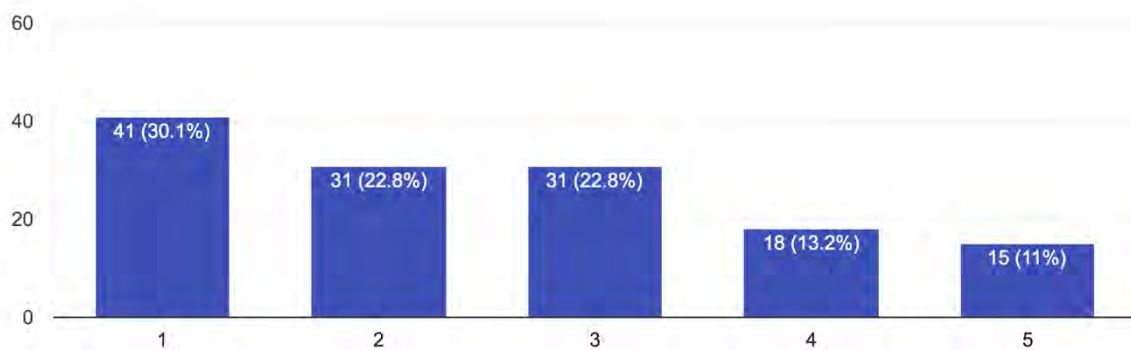

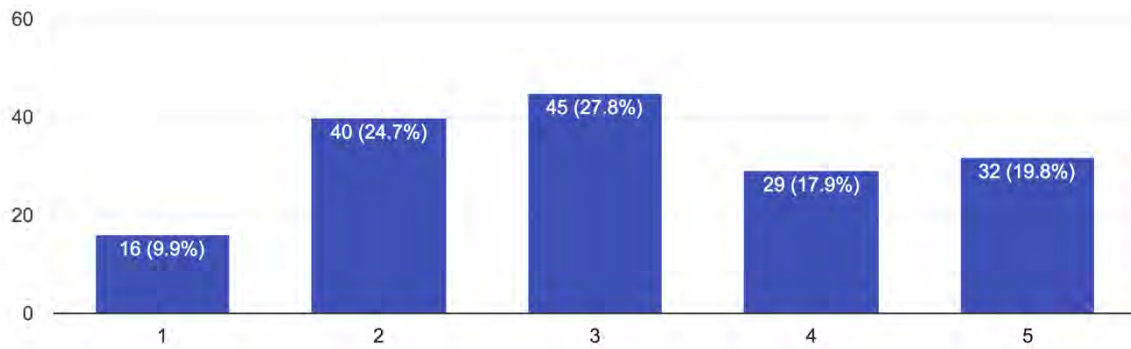

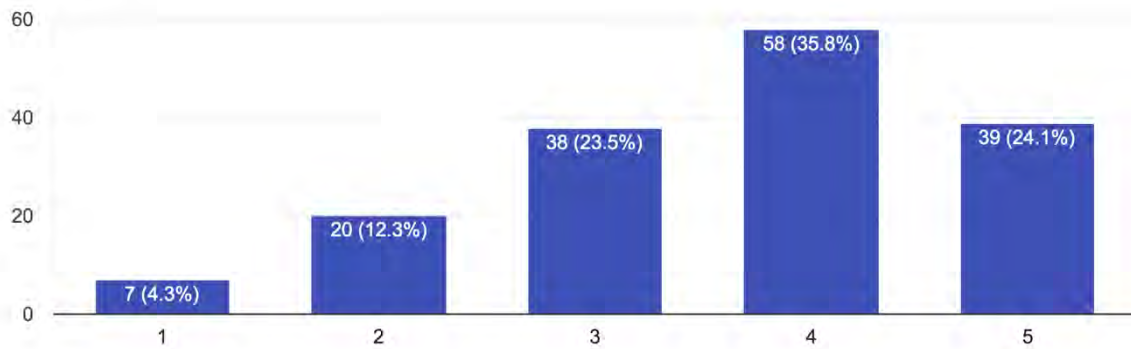

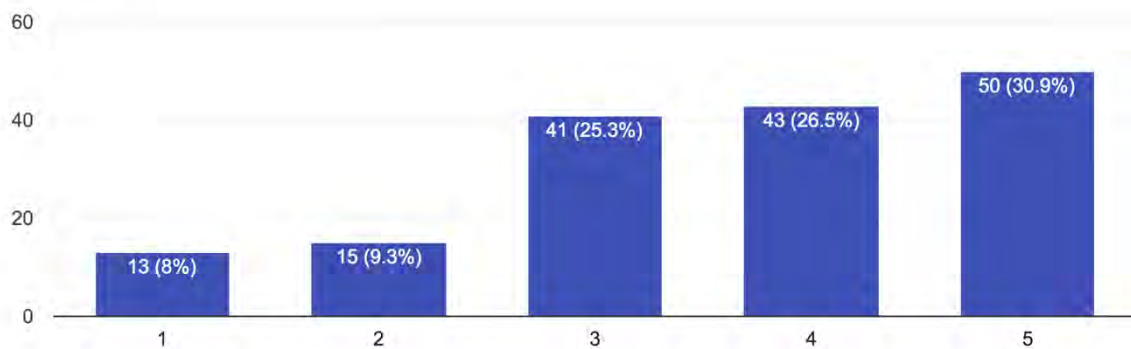

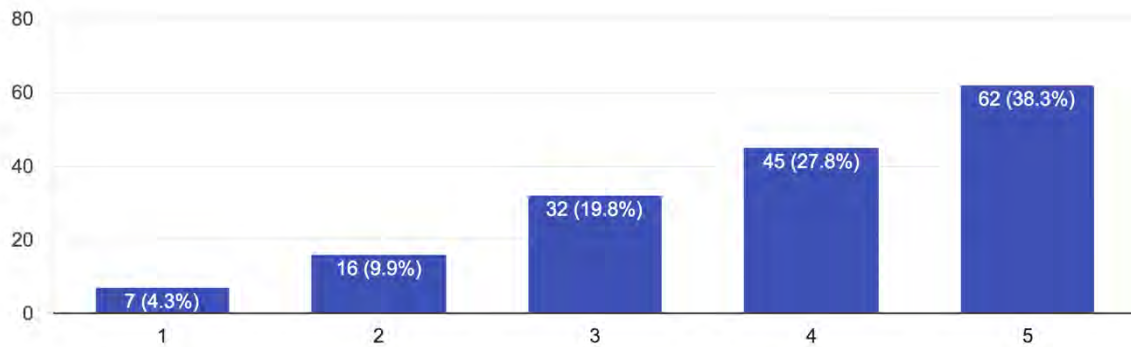

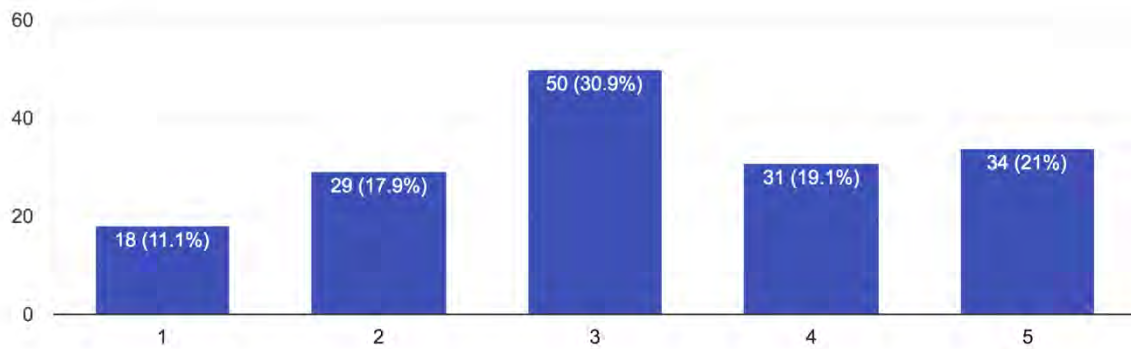

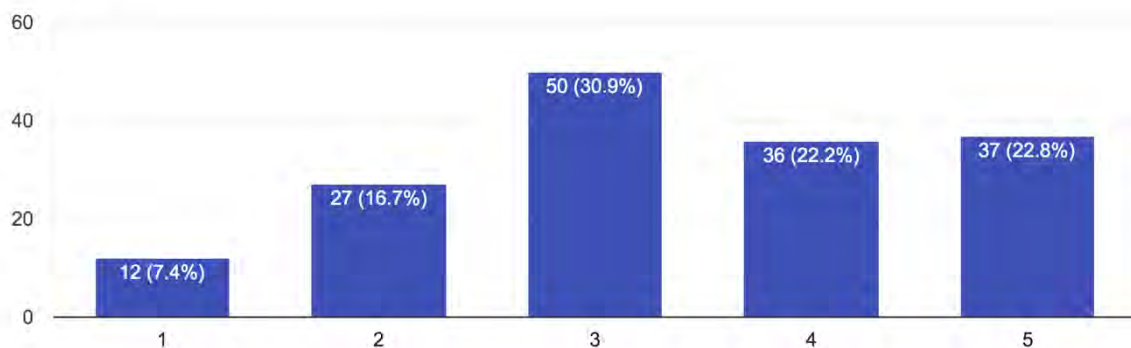

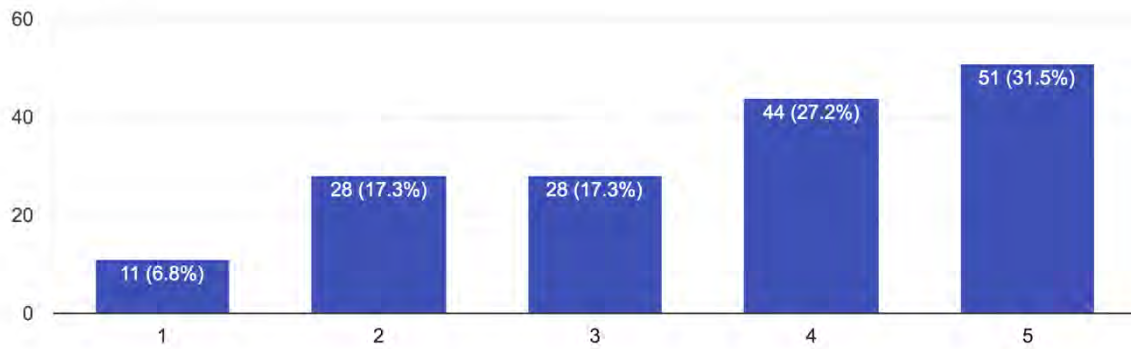

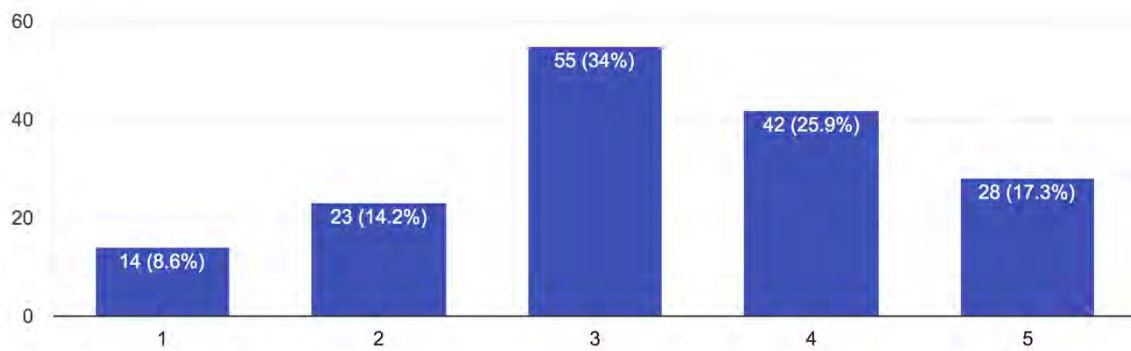

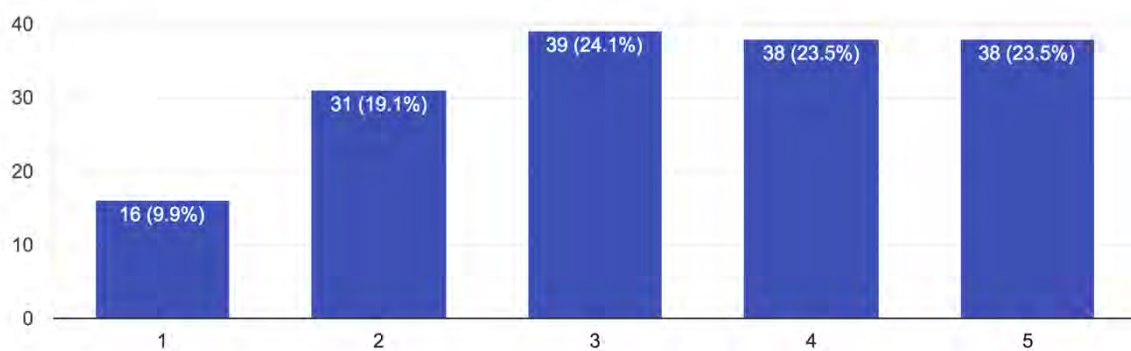

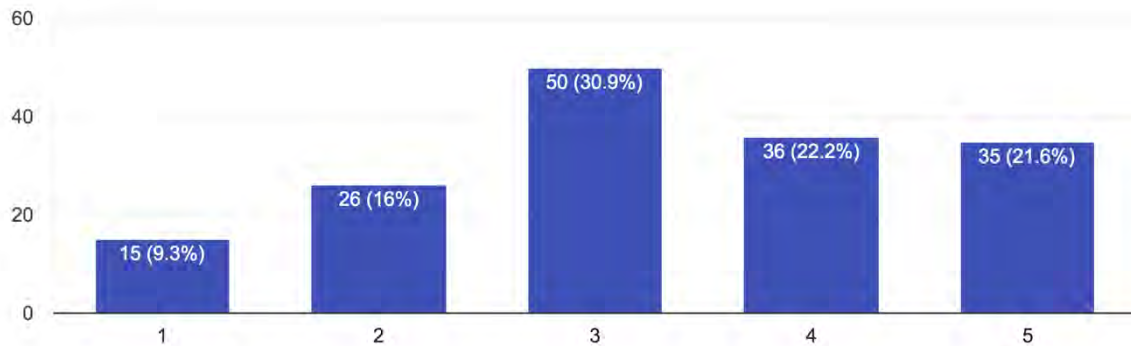

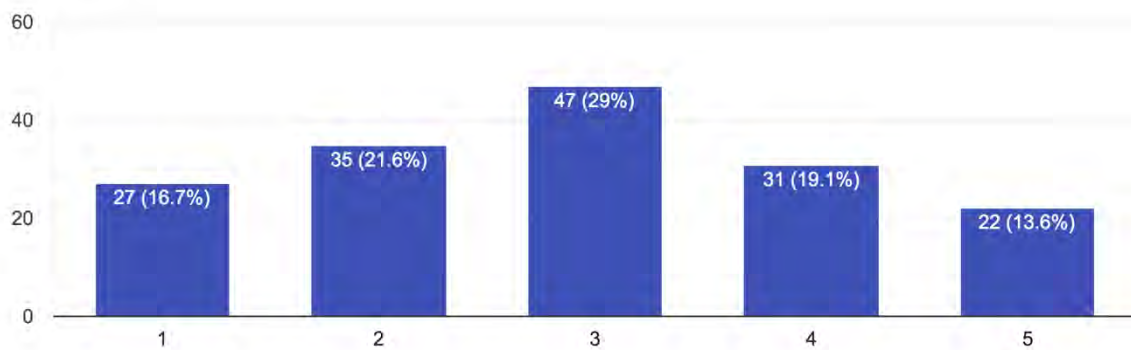

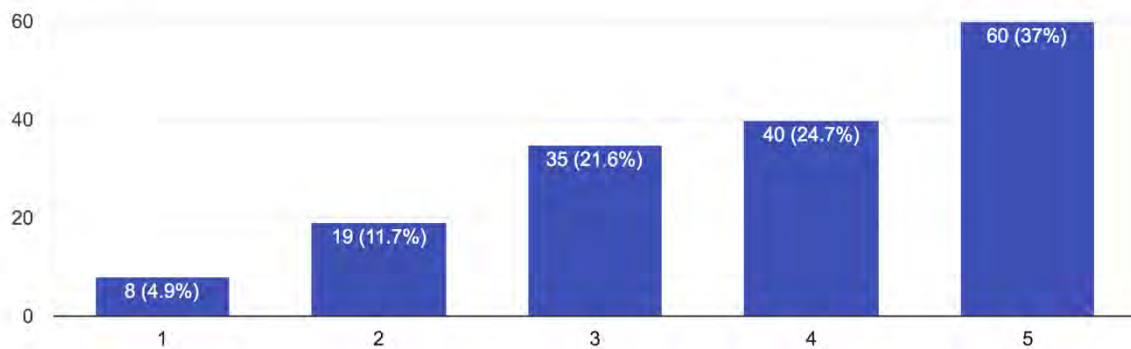

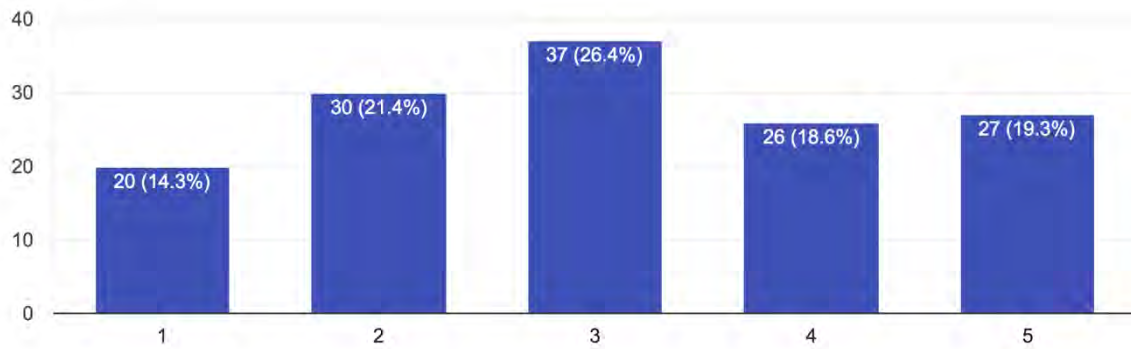

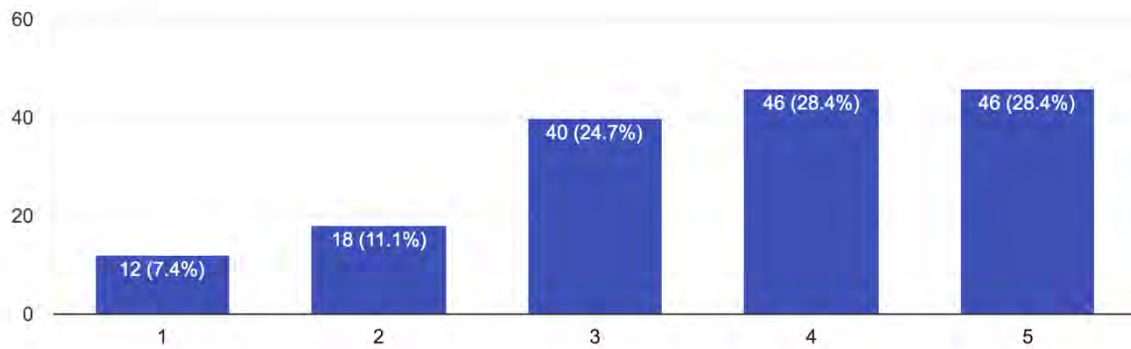

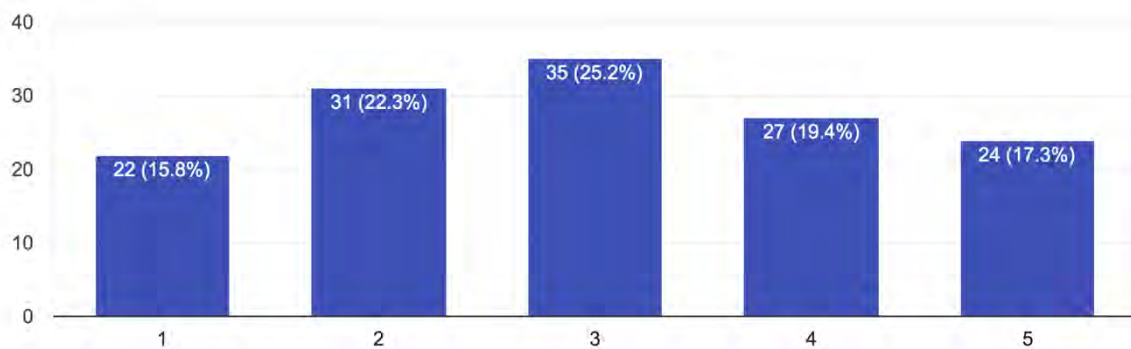

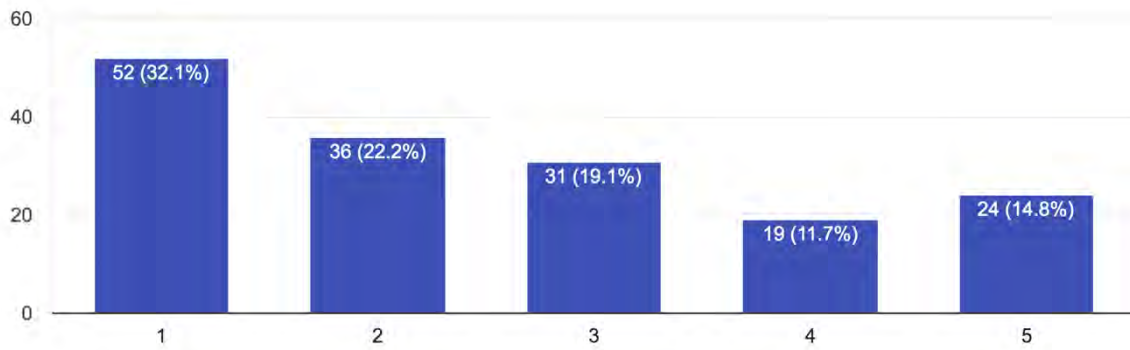

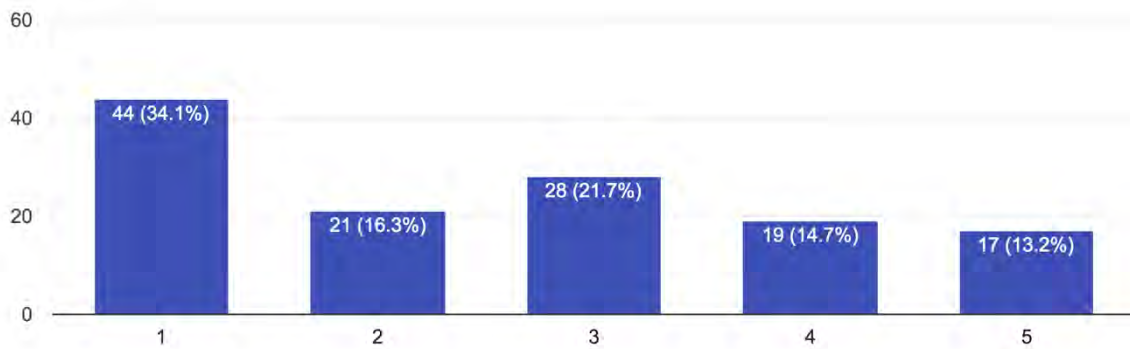

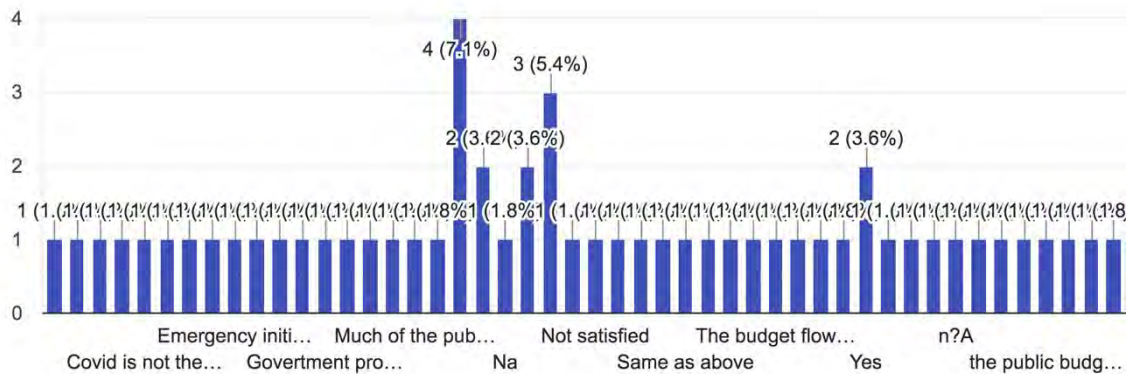

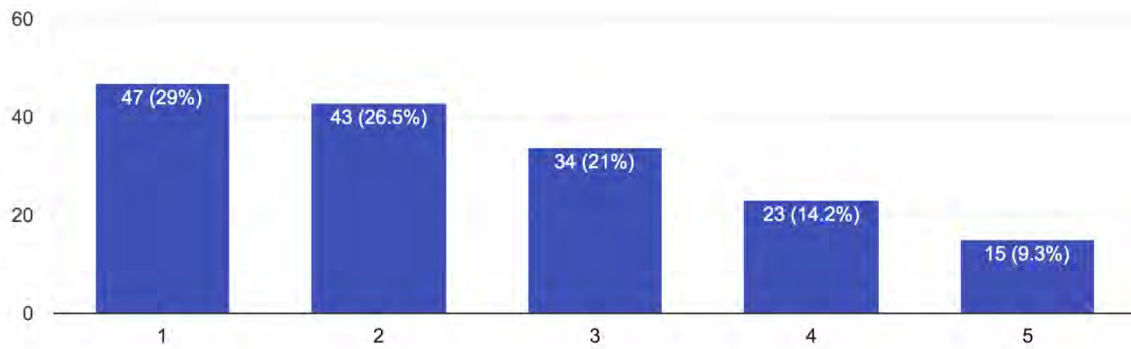

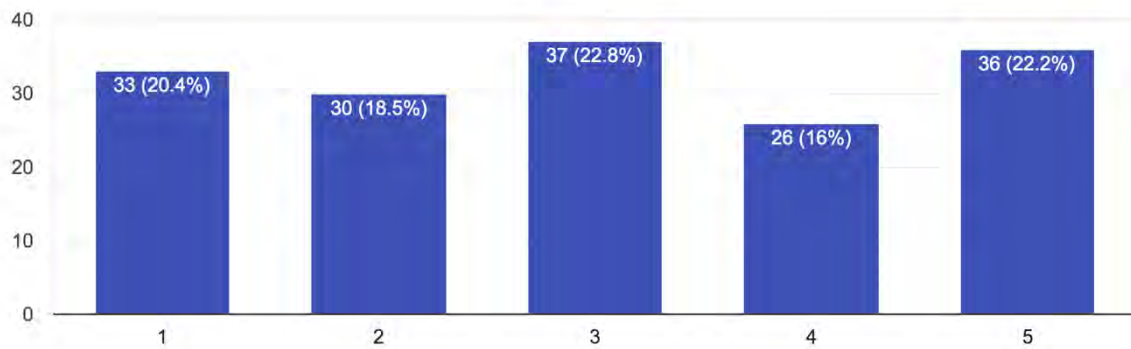

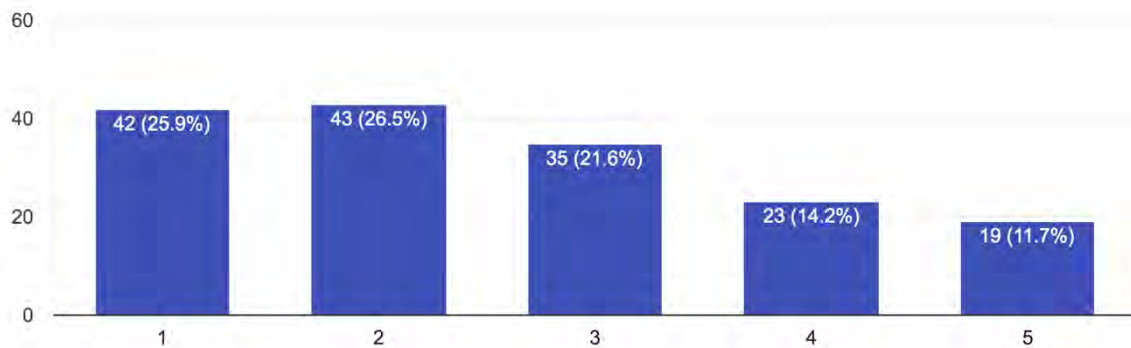

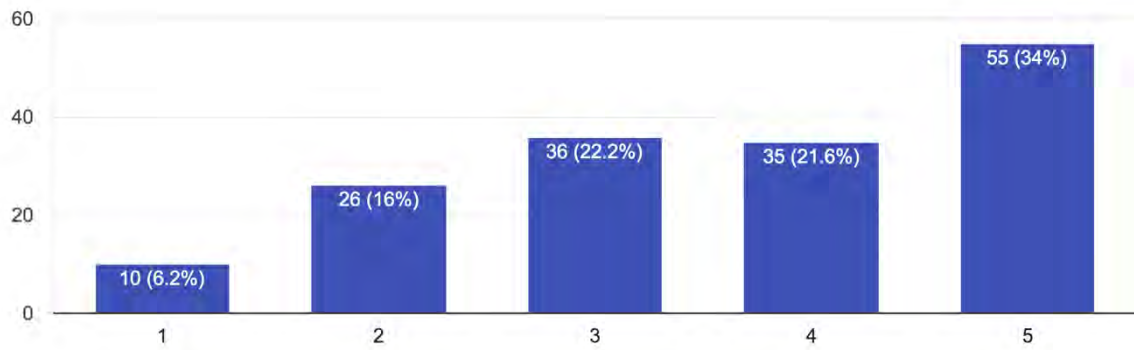

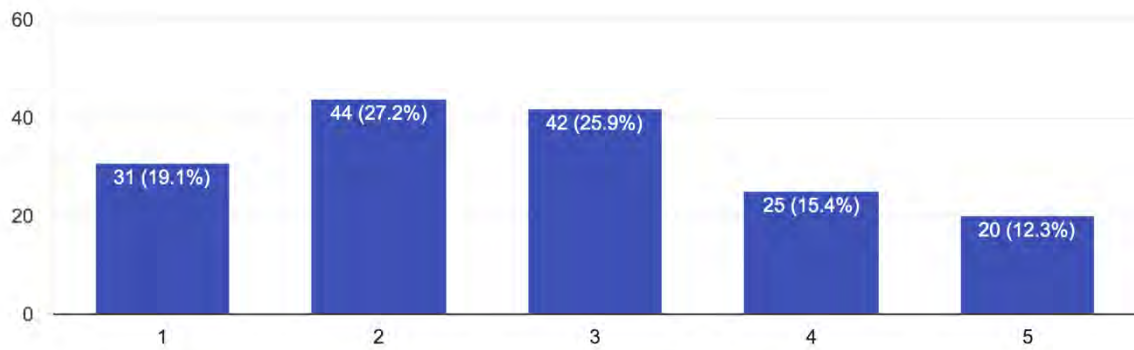

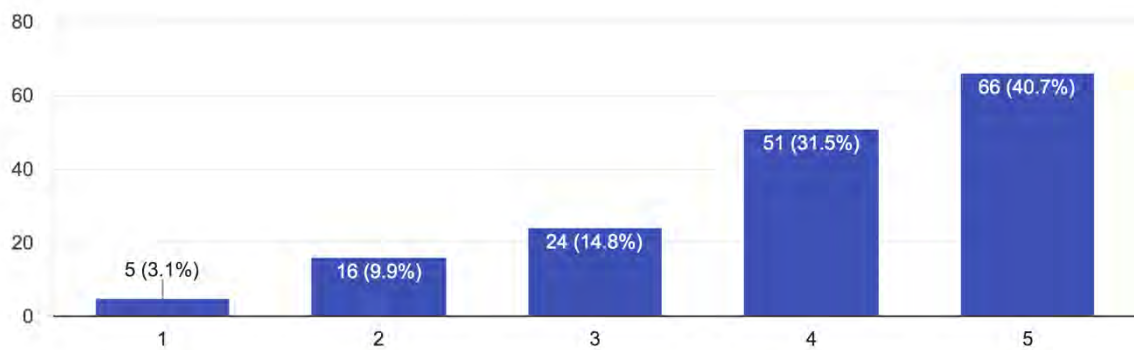

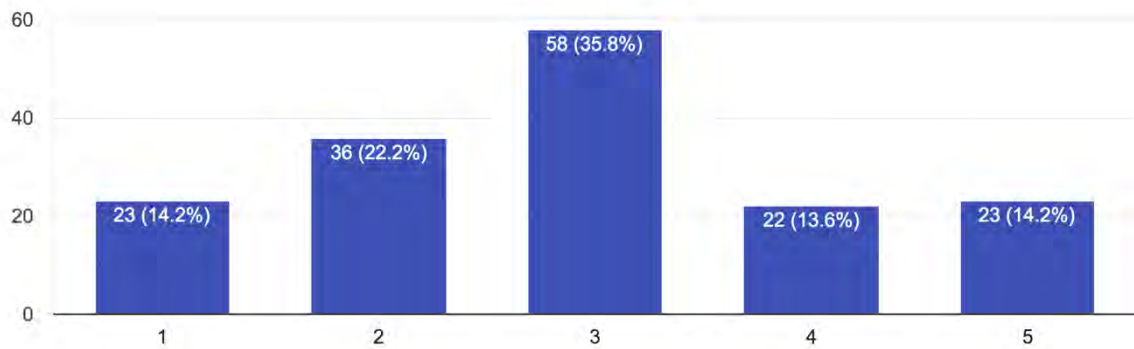

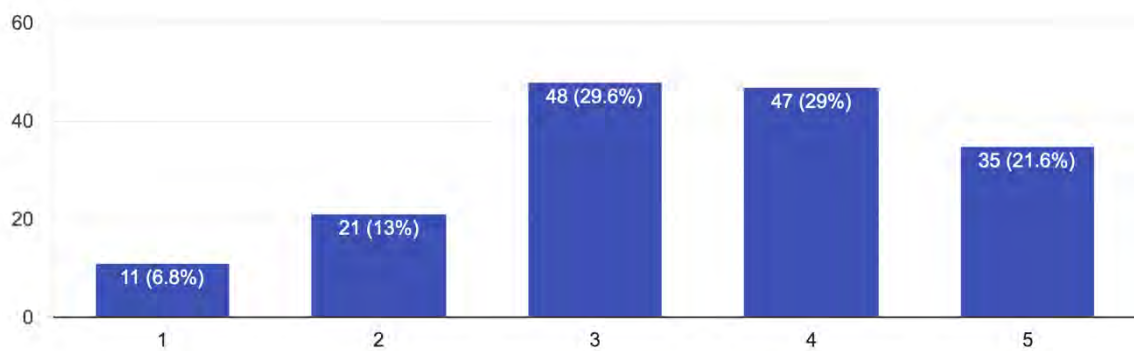

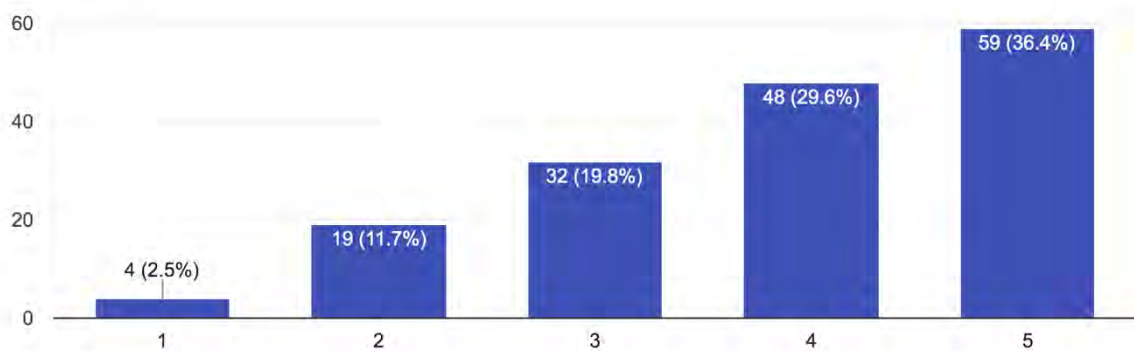

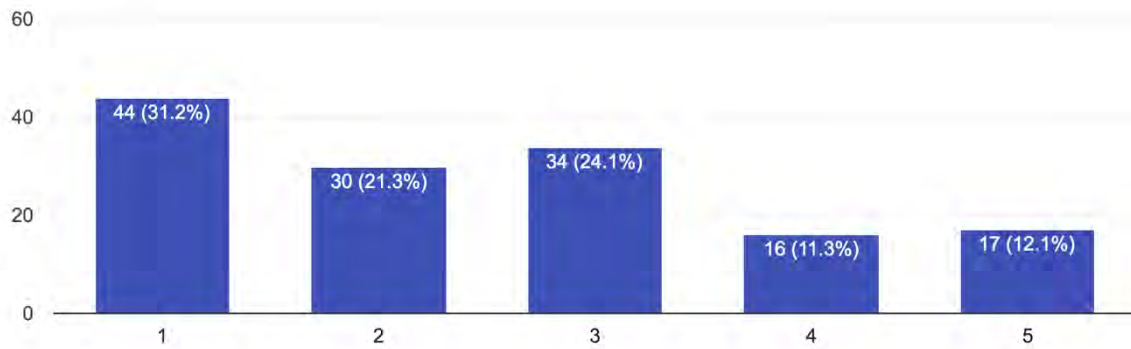

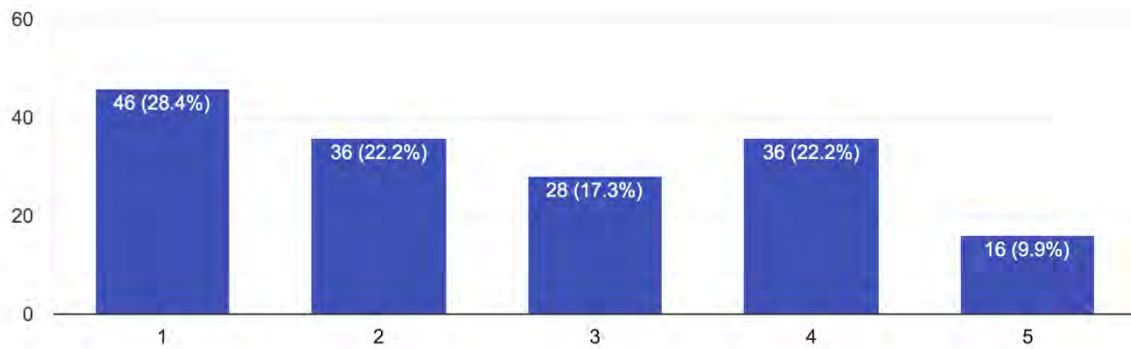

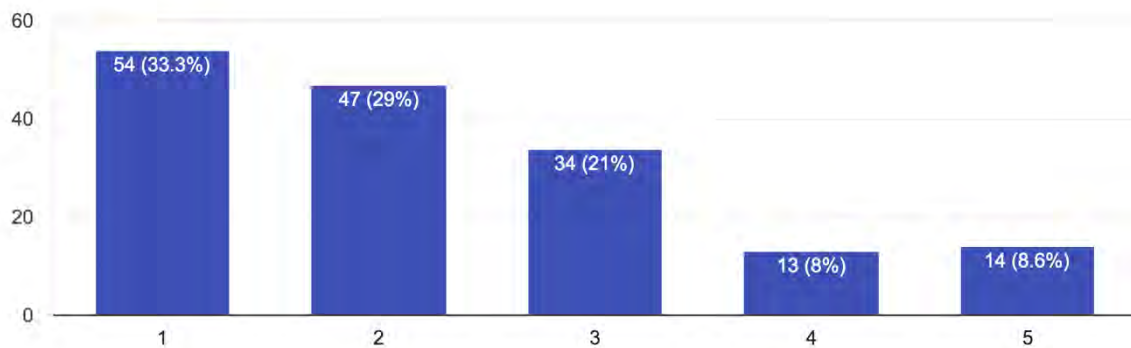

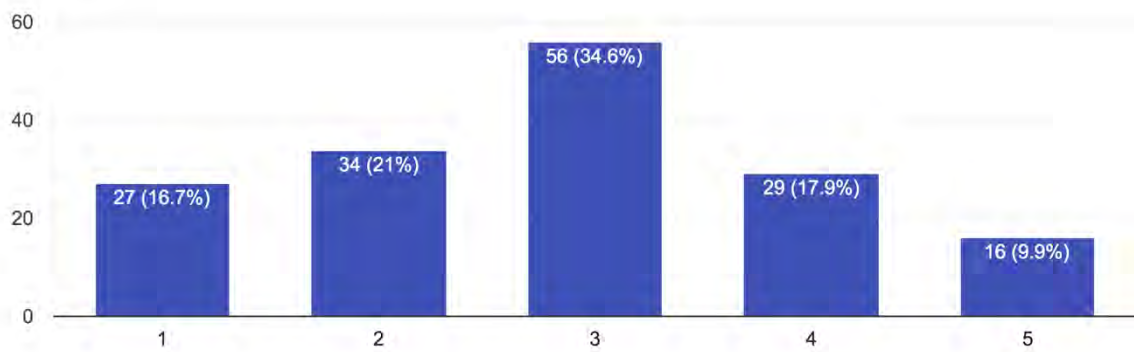

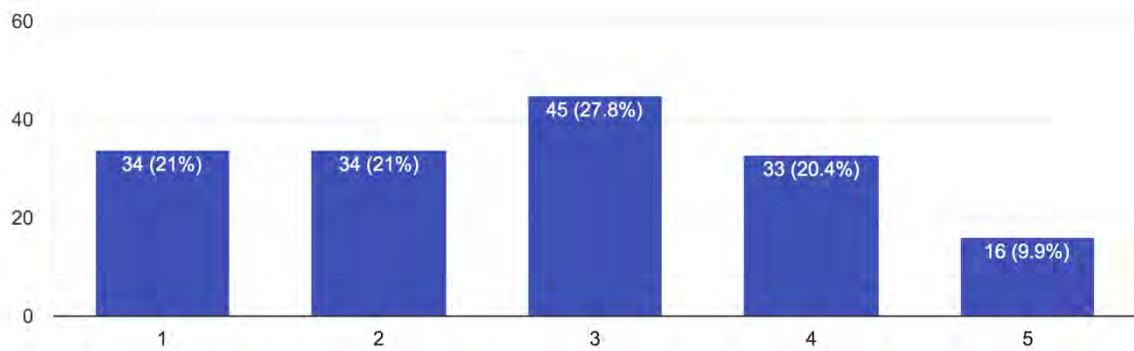
